## Desk & Derrick Club of Tulsa 2011 Energy Essay Contest Rules

Dear Principals, Teachers and Students,

The Desk and Derrick Club of Tulsa is proud to sponsor its fifteenth annual energy essay contest for all public, private and home-schooled middle school students (grades 6-8) within Tulsa County and the surrounding area. Our organization is a nonprofit club affiliated with the Association of Desk and Derrick Clubs (ADDC). The members are employed in the petroleum, natural gas, energy and their related industries within the United States and Canada. Our organization's motto is "Greater Knowledge, Greater Service." We hope that you will participate in the contest. **\$1865 in cash prizes will be awarded to the winning students and their sponsoring teachers for the top ten essay scores.** (See below.)

### CRITERIA FOR ENTRIES:

1. Essay Topic: "*The Impact of the Oil and Natural Gas Industry in Oklahoma*"
2. All essays with completed entry form must be turned in to the student's sponsoring teacher or the Desk and Derrick Essay Contest Committee Chairman. All essays entries must be **postmarked by October 28, 2011 and mailed to:**

3. All entries must be:
  - A. Word processed or typed in 10 or 12 point font or handwritten in **black** ink.
  - B. Double-spaced lines of text.
  - C. On single-sided, 8½ x 11-inch, white sheets of paper.
  - D. No more than four (4) sheets in length for the actual essay. Bibliography may be on a 5<sup>th</sup> sheet.
  - E. Using a one-inch margin all around (left, right, top, bottom)
  - F. Listing a minimum of three sources for material used. (Web sources are acceptable with full URL.)
  - G. Attached to a fully completed and signed entry form. Do not place student's name on actual essay.

**NOTE: THE STUDENT'S NAME SHOULD BE ON THE ENTRY FORM ONLY AND NOT ON ACTUAL ESSAY. FAILURE TO COMPLY WITH THE STATED RULES WILL RESULT IN DISQUALIFICATION.**

4. Each student may submit only one essay that is **entirely composed by the student.**

5. The essay will be judged on the following criteria:



## How One Geologist Rocks the Oilfield

Kristie Luchtel Ferguson started out thinking that she would title her talk more along the lines of “women geologists”. She didn’t really like stereo-typing all women into one category so she reinvented the plan. She styled her talk more about her own personal history from the events of her 15 years in the industry, which has come from many such reinventions.

When Kristie started out in the oilfield, she was practically “thrown” into the rig environment on an almost “sink or swim” track. It probably had more to do with “we don’t know what to do with a girl geologist so let’s see what she’s made of” than sabotaging her learning process as a geologist, who just happened to look different than most geologists at the time. Kristie said that she was even reprimanded on her first paying job for smiling too much. (If you know Kristie, you know that she cannot possibly help that!)

She stressed that above all, we have to be ourselves. Many young women then felt that they had to be as hard core as the men they worked with. Kristie found her own stride by being herself. Even though she didn’t say so in her presentation, I know her personally and feel that because she didn’t put on airs, she found a way to work with men that allowed her to build her reputation as a *competent* geologist; not

just the *girl* geologist. But getting there had its laughs as Kristie shared with us.

"But *actually*, we Love to put our fingers on the Rocks to figure out their stories of deposition so that we can map where the oil and gas is trapped!"

### **Where can a Geo Career Take you?**

Kristie's career has taken her to the following locations.

- Louisiana – where she learned that you can blend in, girls can live on a "no girl" rig, alligators really do live in the swamp, and a guy named "Juicy" might just be the Electrician. From Mike Crumley, her boss at XOM, she discovered the three cardinal *Rules of Working in the Oilfield* : Eat when you can, sleep when you can, and get off the Rig as fast as you can.
- Turkmenistan – where she learned to speak the language and that it all pays the same (dry hole or producer as long as your paid by the foot).
- Venezuela – where she learned about politics in a rich oil country and that not all oil looks and smells alike.
- Tulsa – where she met her husband, started a family and currently leads the Granite Wash team for Newfield Exploration. She recently led a field study to Utah for a large group of company employees. (*It seems that the student has become the professor!*)

Kristie Luchtel Ferguson is a dedicated geologist who enjoys learning (and not just about rocks) and sharing what she

has learned with others. From her presentation, we learned to:

Another item that you may need to address is the updating of the statement on correspondence to solicit donations. The statement should read as follows:



Canadian Clubs operate under the Canadian Income Tax Act, paragraph 149 (1)(l). Contributions are not deductible for federal income tax purposes as charitable contributions; however they may qualify as a trade or business deduction. Contact your tax advisor to determine whether a contribution may be deducted as a trade or business expense.

It is with great sadness that I report, after twenty-seven years, June Warren-Nickles Energy will no longer sponsor the Canadian and U. S. Energy Person of the Year awards. The company's upper management has decided to discontinue the awards; further details are not known at this time. We all appreciate their support and recognition of the achievements of Desk and Derrick members over the years.





## A Review of Senate Bill 1070

I recently attended, at the request of the Red Earth Desk and Derrick Club; a seminar which was hosted by the Oklahoma Center for Nonprofits. I was pleased to go because; 1) I felt honored to be asked to represent the Red Earth Club, 2) the information would also help my home club, Tulsa and 3) as Educational Trustee, the data would be valuable.

The seminar was designed to help employees/volunteers of nonprofit organizations understand Senate Bill 1070. Featured speakers were: Oklahoma State Senator, Susan Paddack; Tamra Laxson, Business Filing Specialist with the Oklahoma Secretary of State; and Tom Bates, Assistant Attorney General and Chief of the Public Protection Unit.

The bill took over two years to design, with a full collaborative working group. Experts in the nonprofit sector, the State Secretary's Office, Attorney General's representatives, The Center for Nonprofits, attorneys with nonprofit experience, nonprofit consultants, Senate staff and Senator Susan Paddack.

"The Oklahoma Solicitation of Charitable Contributions Act is enacted for the purpose of promoting integrity and accountability in the charitable solicitation process; protecting donors and prospective donors who may be solicited for charitable contributions; educating the public, charitable organizations, professional fundraisers, and others in matters relating to ethical and appropriate behavior in fundraising and charitable solicitation activities; preventing fraud and abuse in the fundraising process of charitable organizations and in the solicitation of charitable contributions; and providing transparency to the public in fundraising

and charitable solicitation activities of charitable organizations." \*1

### Speaker Susan Paddack Notes

One important note is that any charitable organization with \$10,000 or less in contributions can file their registration and only pay \$15. Those with over \$10,000 in contributions pay \$65. (I suspect that many Desk and Derrick clubs will fall under the small category.)

Nonprofits that have never filed before have one year to get a registration number.

The Secretary of State's office has been inputting and will continue to update a website, accessible to the general public to provide data about nonprofits.

The registration fee was based on the budgets needed for all three funds: 1) General Revenue Fund of the State Treasury, 2) Attorney General Enforcement Fund and the, 3) Secretary of State Revolving Fund.

Nonprofits are vital to Oklahoma.

### Speaker Tamra Laxson Notes

The registration forms will be "fillable" so that you may complete the form online, print it off, sign it, and send in your check. Be sure to indicate whether this is a first registration or a renewal as it may be returned to you if unanswered.

When renewing, please stay within 30 days of your expiration. Providing the form too early may cause some confusion.

“Same day” filings will be available at an extra \$25 costs. They normally take 15 – 20 minutes to process.

Form 990 will eventually be “scannable”.

### **Speaker Tom Bates Notes**

Violations of the Oklahoma Solicitation of Charitable Contributions Act include:

1. Knowingly making any false material statement or representation on a registration application;
2. Using the name of a person when soliciting contributions or in an advertisement, brochure, stationery or correspondence, without the consent or approval of such person or entity, other than an officer, director or trustee of the charitable organization by or for which contributions are solicited. This paragraph shall not apply to the use of the name of a person or entity that has contributed to or sponsored an event or program of the charitable organization in a report, brochure, program or listing of donors, contributors, sponsors, or supporters issued or published by a charitable organization. This paragraph shall not apply to the use of a public figure’s name or likeness truthfully and in good faith, so long as such use does not imply a false endorsement;
3. Knowingly using, in connection with solicitation of contributions for the purpose of deceiving the public, a name similar to other charitable organizations, professional fundraiser, professional solicitor or government agency or political subdivision;
4. Failing to register as required pursuant to Section 552.3, 552.7 or 552.9, as applicable, of Title 18 of the Oklahoma Statutes unless otherwise exempted by this act;
5. Employing in any solicitation or collection of contributions for a charitable organization any device, scheme or artifice to defraud or for obtaining money or property by means of any false pretense, representation or promise; and
6. Failing or refusing to supply requested information as required by Section 552.9 of Title 18 of the Oklahoma Statutes. \*2


SB 1070 fosters greater transparency among charitable organizations, transparency which allows the general public to make informed decisions about where to send their donations and lets the good organizations continue to do the good work that they do, while helping the enforcement agency to distinguish the good ones from those that may be at risk for fraud. (It was noted that nonprofits with \$10,000 or less in donations may be the source of the most fraud.)

After the panel of speakers, blank registration forms were provided and many questions were asked. While the Oklahoma Center for Nonprofits sponsored this seminar in order to answer questions and allay fears, it was evident to this student that individual organizations still have lots of questions to be asked/answered. No two stories were exactly alike in the Q&A section. It was suggested that if a group had specific issues that were not clearly covered within the bill, they should seek the advice of their own lawyer.

Clearly, the three organizations I represented at this seminar will have its own set of questions. I would suggest a thorough reading of the bill itself and reviewing the handouts from the class. Like any learning process, you have to start somewhere, and this was a great starting place: the source of the bill. I’m fairly sure that all three presenters were part of the full collaborative working group.


