PRESIDENT'S LETTER

Let's talk about tight pants and doing the 'tango. Wait, just kidding! Since we are an energy education club, this letter is an educational moment to learn about a tightening oil futures market and the concept of contango, and its impact on energy jobs and member growth. I will close by mentioning recent employer news relevant to many of our members.

While WTI prices were down in the \$30s and low 40s since January 2016, storage facility owners stocked up on cheap crude oil, hoping to sell it for at least \$2.50/bbl more in a future higher price (see Chart 1 below). However, rising inventory levels of unsold crude creates a dampening effect on prices in the near term, as that inventory takes time to sell off before new produced oil can be sold at current market pricing.

As WTI prices have risen into the upper \$40s per barrel in July, something is happening in the oil market right now that indicates supply and demand are coming more into equilibrium. The contract for the sale of oil or gas shows a volume to be delivered in each future month. A situation called "contango" arises when contract prices on future deliveries are higher than the current month's deliveries. When a large price gap (contango) exists, storage owners like those in the port of Catoosa have incentive to fill or hold inventory waiting to sell it at a higher price later. The degree of contango is thus a qualitative indicator of the level of a market's "oversupply."

What we saw in late July is *less* profit incentive for storage tank owners to hold inventory due to the narrowing contango of only \$0.36/bbl in the next six months (see chart below). That narrowing of the price of today's volume deliveries versus the next six months of delivery pricing shows a closing of the price gap. This indicates a tightening of supply and demand in the market, meaning it's coming into more of an equilibrium rather than a huge supply glut we have seen for the past two years.

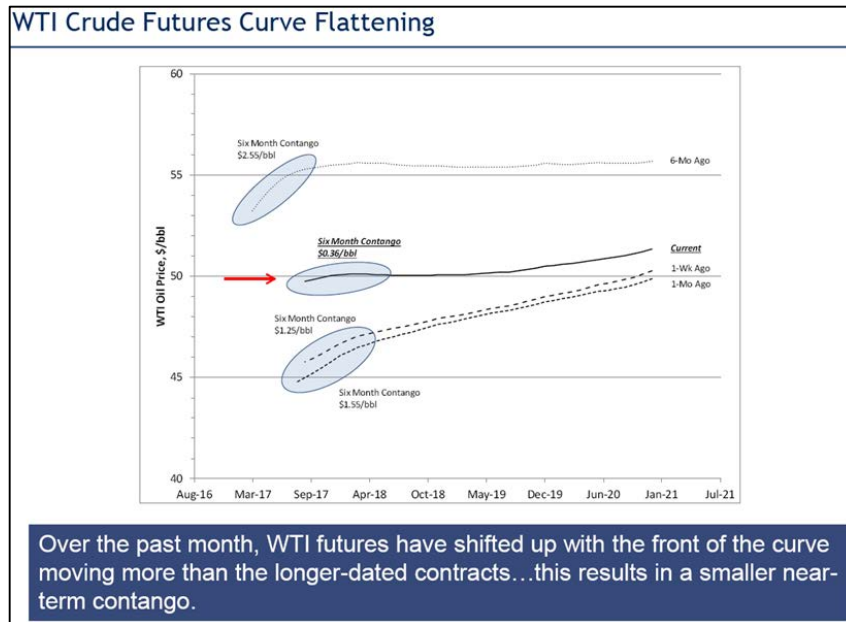


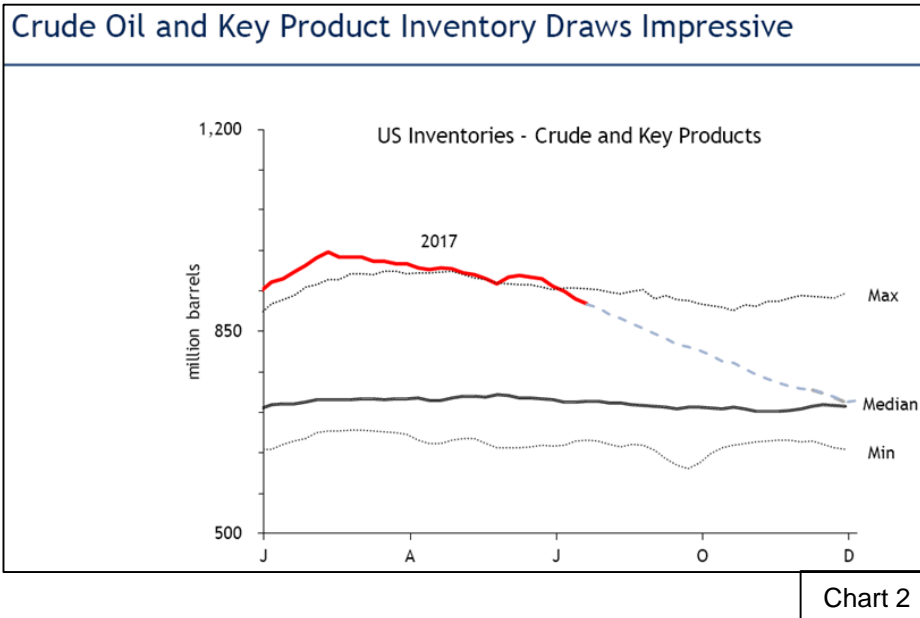

The tightening (smaller) spread of future profit gives less incentive to storage owners to hold inventory, so they sell it off. The decline of US crude oil and refined fuels inventory accelerated in July. In August, Saudi Arabia will tighten the market further by reducing their August exports into the US, allowing US stored oil and gasoline inventories to continue to be sold off and decline. In summary, the contango of

the forward price curves in the NYMEX WTI for crude oil future is “flattening” in July as inventory is drawn down. What does all of this mean? Price is stabilizing around \$50/bbl. Total inventory is still well above the 10-year normal level, but at least the market is self-correcting somewhat in a positive, stabilizing direction. TPH estimates based on their EIA research that US inventory may fall to a normalized level by the end of 2017 (see “D” for December in Chart 2 below).



If prices can stabilize above \$50/bbl, we should see more capital investment and job creation in the energy sector, something that all of our members can appreciate. I am excited to see the contango tightening and the market pricing firming up in July. Price stability and job growth is a positive outlook for the future of the Association and attracting new members.

As a final note, I wanted to mention the performance of a few local companies who employ the largest number of our Tulsa members.

1. Cimarex Energy has underperformed in the past year, but it has strong prospects with a competitively low debt leverage ratio (0.8x vs optimal 1.0x), a high rate of return in the Northern Delaware basin and a 30% expected revenue growth rate (vs. 20-27% peers). Despite some of its peers (FANG) using its investor capital more efficiently, Cimarex is a strong long-term employer.
2. Laredo Petroleum announced a process in July to sell its investment in Medallion, a pipeline. TPH speculates that this sale could bring in cash proceeds to significantly reduce its debt and/or expand future drilling opportunities.
3. Two private drilling operators in Tulsa moved forward with development of recently acquired leased land, firming up the job outlook for those members.

Thank you for letting me share an energy learning moment about pricing contango on future deliveries. Enjoy the news of supply and demand equalizing, but most importantly, go tell someone about D&D today!

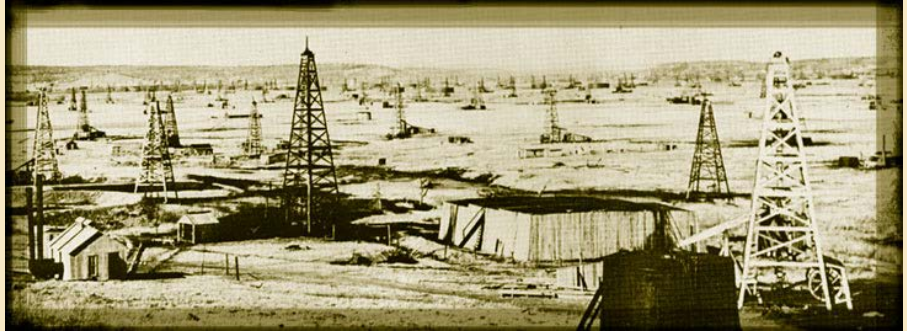

THE GLENN POOL FIELD

In 1900 the state of Oklahoma boasted 780,391 citizens and Tulsa reported 1,390 residents. Ten years later those numbers doubled to 1,657, 155 for Oklahoma and increased thirteen fold to 18,182 for Tulsa establishing it as the foremost oil town in the state which title it has maintained. Massive oil discoveries



in Oklahoma during that ten year period created the fantastic population spurt which began with the state's first major oil play; the Glenn Pool Field near Tulsa.

In 1901 Charles Galbraith was involved with the minor oil discovery at Red Fork just outside Tulsa and that summer began looking for more prospects in the same general area. By July he had located what he felt was a good location on the Ida E. Glenn farm about twelve miles south of Tulsa and four miles southeast of



Sapulpa. However, he delayed leasing the property which was on Creek Indian Land for four years until legal restrictions concerning drilling on Indian lands eased somewhat. Galbraith and his partner, Frank Chesley, began drilling on the Ida E. Glenn #1 in the fall of 1905. They completed the well on November 22 at a depth of 1,481 feet in the Glenn sand formation (soon to be renamed the Bartlesville sand) for a production of seventy-five to eighty-five barrels per day. Galbraith had insisted that the well be drilled in the utmost secrecy in order to avoid the absolute chaos that developed around Red Fork boom a few years earlier. Nevertheless, word got out almost immediately and the first gigantic oil boom in Oklahoma history resulted.

By the summer of 1906 the fifty to one hundred rigs running in the field were producing such a massive amount of production that the various operators called a meeting in Sapulpa where they officially named the field. All that production created somewhat of an emergency when inadequate storage and the absence of pipelines to ship the production out caused much of the oil to be stored in giant earthen pits where vast amounts overflowed and flooded the countryside. That overproduction in turn caused the price of oil to drop as low as twenty-five to forty cents per barrel while the cost of producing it was in the thirty cent per barrel range. During the first year the size of the field grew from the original eighty acres to more than eight thousand acres and ultimately covered an area roughly four miles long by two miles wide. The flush production period of flowing wells ran from 1906 to 1908 when Glenn Pool regularly produced from eighteen to twenty million barrels per year. The 1907 production of 43,580 barrels made Oklahoma the nation's leading oil producer, a title it maintained until 1928. By 1908 the natural gas which caused the wells to flow had been vented to the extent that the wells ceased to flow and were gradually transferred to pumps. About that same time all the waste began to come under control as the Prairie Oil and Gas Company, the Gulf Oil Company, and the Texas Company (Texaco) all established pipelines in the field to ship the production to market.

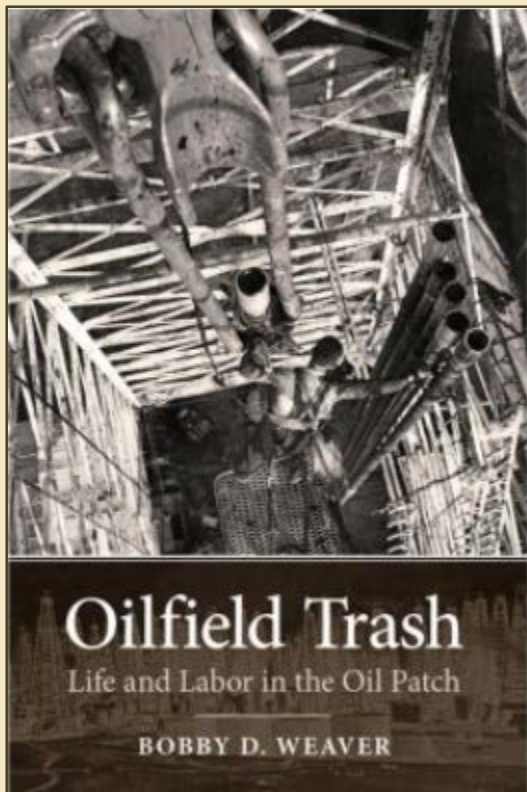

The Glenn Pool witnessed the beginnings of the careers of several legendary oil industry figures such as Harry Ford Sinclair who later founded the Sinclair Oil and Refining Company as well as J. Paul Getty of Getty Oil Company fame. Closer to home the Oklahoma Natural Gas Company was formed and in 1907 it built a pipeline from Glenn Pool to Oklahoma City to provide gas service to the capital city. A number of boom towns developed including Sapulpa which almost overnight mushroomed from fewer than a thousand souls to more than eight thousand. At the height of the boom Sapulpa had more than thirty trains per day stopping as well as serving as the hub of an interurban line that provided access to the field. Newly formed towns proliferated. Keifer with its notorious reputation for lawlessness was established as the major terminus for the Gulf pipeline and with the passing of the boom began a decline that ended in the 1980s when it became a suburb of Tulsa. The village of Mounds grew by leaps and bounds, Jenks was established in 1905 as the terminus for the Texas Company pipeline, and Glennpool was founded in the fall of the following year and survived as a viable town for the rest of the twentieth century. Others such as Sabo which did not survive the boom were not so lucky although Taneha (later Bowden) managed to hang on from its founding until 1957 when it also became a memory.

July Presentation Recap

Art Deco 101

Presented by Ann Thompson,
Guardian at Tulsa Historical Society and Museum

Ann showed us examples of the three styles of Art Deco that we are fortunate

to have in Tulsa. The **Zigzag** style that was built in the 1920s emphasized strong vertical lines and geometric patterns. Examples of this style would be Boston Avenue Methodist Church (pictured left) and the Philcade Building (pictured right) at 5th and Boston. Don Wagner, who authored a book listing Tulsa's Top Ten in Art Deco, said that "Tulsa's Art Deco is the integration of history, architecture and art. It represents the prosperity and wealth experienced in Tulsa during the 1920s due to the discovery and development of the oil industry."



During the early 1930s, the **PWA (Public Works Authority)** style emerged and was funded partially with public money in a period as we tried to recover from the Great Depression. The PWA style is usually defined by monumental size.

Examples of this style would be Webster and Will Rogers High School (pictured left), as well as the Armory and the Pavilion at the Tulsa Fair Grounds (pictured below).



Ms. Thompson shared that the Fair Grounds Pavilion was her favorite example of Art Deco in Tulsa and after she showed us the pictures both in her Power Point presentation and her own pictures that she had compiled of Tulsa landmarks, I have to admit that I have more of an appreciation of the beautiful building with its colored terra cotta panels that depict horses, cattle and rams.

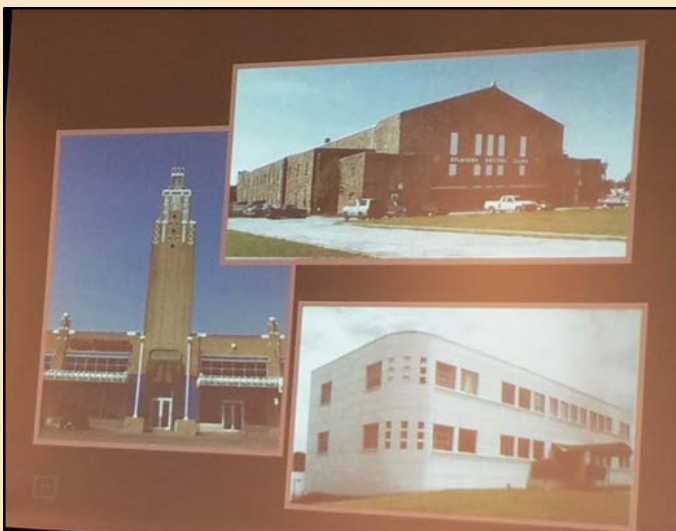
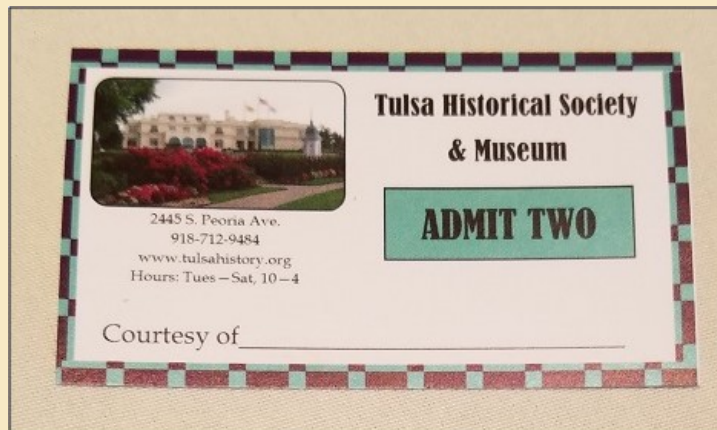

This style is more horizontally oriented and typically features aerodynamic flowing curves. Some examples of this style would be The Brook Restaurant and City Veterinary on Peoria (pictured right).
