

Welcome to 2016 from President Karen Gibbs

Dear fellow Club members,

Honestly, it is my great privilege and honor to work with you as we maneuver the days, weeks, and months ahead.

Thank you for putting your confidence in me as you make a commitment to Desk and Derrick. Together we will continue to work towards growth and education in this neverending and ever-changing industry. The highs and lows come and go, and still this Club has preserved for over 60 years...and with everyone joining together, we can ensure that our Club is around for younger generations in years to come.

My Papa was a coal miner in the hills of Alabama. Back in the depression era, Roosevelt formed the Public Works Administration (aka WPA), which provided money for jobs in the early, new stages of coal mining. It was either the coalmine, or the sawmill. Papa chose the mines. He got up before the rooster crowed, put more wood in the stove, and stoked the fire to blazing so Granma could cook his biscuits and gravy before he hit the mine at 6 a.m. each morning – six days a week, sunup to sundown. It was hard, backbreaking work, and a lot of times he was on his knees crawling through narrow tunnels, his headlamp only dimly showing the way around the next rock group. Still, he was glad to have a job.

It was a time of excitement, but also just as dangerous, as families and workers soon came to realize. This was a "new deal"; the opportunity to resurrect themselves from the heartbreak of bad times, and the too familiar word, "bankruptcy", which most folks faced. Those were dark times, but the light of coal in the fireplaces and kitchen stoves brought the welcome warmth and the Light. There was encouragement; Papa told me.... this will be a way we can once again pull ourselves up by our bootstraps and keep on going.

Here is an article written by William C. Pryor in 1938, promoting Roosevelt's WPA in the hills of Alabama, Mr. Pryor reports....

There is in fact nothing beautiful in Carbon Hill, Alabama, but the spirit of the people. That, however, seems to be quite enough to have enabled the town to survive through a period of economic disaster and the people we talked to were practically unanimous in feeling that the Administration has saved the town from oblivion and they were, therefore, grateful. Whether the town can ever depend again entirely on the income from the mining industry and get along as it is now is a question . . . but if the courage and the will of the people mean anything they will make a good try.

We must also make a good try. We can also once again pull ourselves up by our bootstraps and keep on going. There will be a Light. It might be a while coming, but it will come.

The Industry Appreciation Luncheon theme in November was spot on about our "now" times. What do we do now? Where do we go from here? What is going to happen next? We might not be able to control the oil or natural gas prices or the number of jobs that have been eliminated. We can only see through the dimly lit path ahead of us right now, but there will be a Light at the end of the tunnel. And it will NOT be another train. There will be good economic times once again.
