

Eagle Energy Company, one of the fastest growing Exploration and Production Companies in the country, was one of the early pioneers in horizontally drilling the Mississippian formation in Oklahoma's Anadarko Basin Shelf Area within a leasehold position that ranks them as one of the largest leaseholders in the trend and one of the most prolific operators. Growing through the drill bit to gross production exceeding 10,000 barrels of oil equivalent per day in less than three years, Eagle ranked 3rd in the *Oklahoma Journal Record's* "Fast 40" list of Tulsa's fastest growing companies for 2011.

Prior to founding Eagle in 2009, Steve Antry was Founder, Chairman and CEO of Beta Oil & Gas, then merged Beta with Houston-based PetroHawk Energy, providing their initial platform that ultimately placed PetroHawk as one of the top 25 oil and gas producers in the U.S. and attracted the sale to BHP Billiton for \$15 billion.

Mr. Antry has over 30 years of industry experience and is from a third generation Oklahoma oil family. He received his BBA and MBA from Texas Christian University. He was a nominee for Entrepreneur of the Year for 2011 by the accounting firm of Ernst and Young and is a finalist for this same honor for 2012. The Port of Catoosa Presented by Bob Portiss – Port Director Authored by Thelma E. Dunn

Bob Portiss of the Port of Catoosa gave an EXCELLENT presentation in June about the port. He was extremely knowledgeable, very good natured, and passionate about the mission and purpose of the Port of Catoosa. As I listened to Bob, I noticed that several Members were making notes of the information that he was providing; and boy, did he provide information. One of Bob's opening statement was that the Port of Catoosa brought the ocean to Tulsa. I thought it a very odd statement at the time; however, Bob was able to justify that statement by the end of his presentation.

The idea for the Port began years ago. In the late 1960's, investors approached the councils of Tulsa County and Rogers County with the idea for the Port and asking for \$121 million to build it. They made a pact with the counties that if they provided the money as requested, they would not be back again asking for more money. To this day, the owners of the port have kept their word. In 1971, President Richard Nixon visited the Port of Catoosa, and in his speech he said, "It's a pleasure to be here on Oklahoma's Seaport."

The first thing that the committee did before work was begun on the port was to visit other ports already operating. They asked those ports what they did right when they built their port, AND also asked them what they did wrong. They were willing to learn from the mistakes of other ports to make the Port of Catoosa better.

The Port of Catoosa is one of five major ports along the Verdigris, White, Arkansas and Mississippi Rivers. From the Port of Catoosa, cargo can move towards the Mississippi River to the Gulf of Mexico and then to either ocean to any country in the world. There are 18 locks and dams on the McClellan0Kerr Arkansas River Navigation System, which was named by an Act of Congress on January 5, 1971. There are 18 locks and dams in the system—13 in Arkansas and 5 in Oklahoma. The system was designed for 8-barge tows.

One jumbo barge has the same capacity as 15 railcars or 60 semi-trucks. It can carry 1,500 tons of cargo or 52,500 bushels of grain or 453,600 gallons of liquid. Bob said that the line of semi-trucks would be 35 miles long carrying the same amount of cargo as one barge.

Crude oil shipped for the very first time in 2011. Barge Tonnage equals 5.5 million tons (4,00 barges annually—enough cargo for 240,000 trucks). The port also has 160- wheel carriers which transport transformers from the Low Water Wharf to their final destination in Chouteau. The barges can also transport moisture separator reheaters, which are used to increase electrical output in nuclear power plants. These reheaters weigh 555,000 pounds each. They are too large to go by truck or railroad to the Grand Gulf Nuclear Station in Port Gibson, MS. The waterway is the only mode of transportation to carry these HUGE, HUGE reheaters.

Yes, the ocean has come to Tulsa to enable our industries to be able to ship their products to any country in the world at a much lower cost than shipping by truck or by railroad. Hearing about the Port of Catoosa gave me pride knowing that the Port of Catoosa is indeed a third "ocean", and it is right here in our home town!!
