Presentation Recap - May 8th, 2013

What is Non-Destructive Testing In the Oil & Gas Industry?

Mark Winner, the General Manager of Tulsa Gamma Ray, Inc. gave a short presentation on Non-Destructive Testing (NDT). It is also known as Non-Destruction Inspection (NDI) and Non-Destructive Examination (NDE). The basic definition is an analysis technique used to evaluate the properties of materials for flaws without harming the object being tested.

Various industries utilize this service including oil and Gas The technique can be applied to a sampling or used for 100% checking of the material. The various tests include radiographic, liquid penetrant, magnetic particle, ultrasonic, visual and positive material identification tests.

Certification of NDT personnel is at three levels. 1.) Perform specific tests. 2.) Set up equipment, prepare written instructions and report test results. 3.) Establish techniques, interpret codes and designate methods to be used.

The requirements for an inspection are visual acuity, proper lighting and time. The requirements for the evaluation are size, length/width, diameter, linear indication, location and color.

His power point included several optical illusions to demonstrate that you can't always believe what you see; demonstrating that a visual inspection will not always reveal flaws or concerns.

He also presented several slides showing examples of flaws in welding seams and the different nomenclature for these flaws.

You're probably thinking that this article has been miss-titled; that it should be, "Tree Growing – 101". If it were truly about trees, you'd be right. I suppose it is more about team building than tree building. Please indulge me.

Eight members of the Desk and Derrick Club of Tulsa recently attended the 2013 Region VI Meeting, which was held in Enid, OK. (Most of you are aware that our club is among the 11 clubs within that region, consisting of over 400 members.) Our leader, Region VI Director Anna Lewis-McBeth, determined early in her reign that her motto would be, "Branching Out for Energy Education."

As the Region VI Representative for the Contest Committee for the Association of Desk and Derrick Clubs (ADDC), the duty fell to me and the Committee Chairman, Sharon Funk from the Butler County, KS club, to help create an awards contest. With eight categories and three places (1st – 3rd) to be announced among 11 clubs, we started to think about how to save time but cover all of the awards. Plus, we wanted to make it a memorable event for the winners. Our writers/speakers/program coordinators don't receive any money for their efforts so what recognition they get comes from our individual clubs, our region, and hopefully from the Association. (Remember that all Regions' first place winners go to the next level of judging before the Association Convention, which is held in the fall of each year. (2013 ADDC Convention will be Charleston, West VA.)

Our script was short and consisted mostly of calling out the names of winners. What seemed to work for us was that we had a "visual aid" that doubled as a photo opportunity for winners--**a tree**. Our awards were live trees for first place (in honor of Arbor Day), a live plant for 2nd place and a packet of seeds for 3rd place.

About now, you're wondering how we got a tree to Enid or how we moved it from my room to the Banquet Hall or how we even "built" the thing. I can tell you this—it didn't just fall out of a dumpster. (Actually part of it did fall out of a dumpster as a road sign from last year's contest, and we decided to recycle it!) My co-worker and fellow Desk and Derrick member, Brenda Bennett, helped me search the web in order to build on the initial project idea. The base was made from PVC pipe (a petrochemical, by the way). The branches were designed by my husband out of PVX pipe (another petrochemical). We painted the pipe brown to resemble a tree trunk and branches. I used a Cri-cut to cut out over 200 leaves. All that was left to do was glue the leaves on, but it seemed like an overwhelming chore to me—gluing 200 leaves on, which I decided to do once in Enid. Typical of me, I procrastinated until the last minute. The contest would be held on Saturday night. As of late Friday evening, I had not yet glued down one leaf. I casually mentioned to my fellow club members that I needed assistance. True to their reputation, they all arrived at my hotel room to finish assembling the tree. Some leaves were even tied on as to give it another dimension. I must say we had too much fun while we were working—and I really don't think it was the glue dots.

It reminded me of all the crazy things Tulsa members have done in the name of Desk and Derrick. We've dressed as grapes (decorated in purple balloons) while dancing to, "I've heard it through the grapevine that you want to come to Tulsa", when making a bid for Region Meeting. We've used hula hoops, a sheet and a horse costume to create the illusion of a wagon while bidding to host an ADDC Convention. We've dug for fossils on the hillside of a lake. We've welcomed each others' children and we've attended each others' weddings. For Team Tulsa, tree building was a cinch!

We are not there yet, but we are definitely *on our way!*

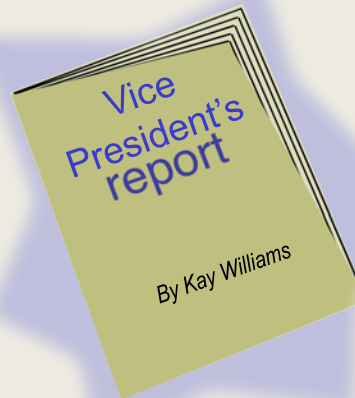

Speaking of seasons, this time of year is also a time for tornadoes. Pretty much every year we see how deadly and destructive a tornado can be. Etc...Some may say that the cost to make this possible is too costly but what value can we truly put on human life? To me, no value can equate to how precious one's life is so I truly hope to soon see some changes in the way homes/buildings are built to provide more safety during tornadoes.
