### **BLM REQUIREMENTS FOR SURFACE RESTORATION AND RECLAMATION**

The definition of Bureau of Land Management according to Wikipedia is an agency within the United States Department of the Interior that administers America's public lands, totaling approximately 247.3 million acres, or one-eighth of the landmass of the county. The BLM also manages 700 million acres of subsurface mineral estate underlying federal, state and private lands. Most public lands are located in Western states, especially Alaska.

The BLM's stated mission is to sustain the health, diversity and productivity of the public lands for the use and enjoyment of present and future generations. History background from BLM website: The BLM's pure roots go back to the Land Ordinance of 1785 and the Northwest Ordinance of 1787, Mineral Leasing Act of 1920, Federal Land Policy and Management Act of 1976.

Desk & Derrick Club of Tulsa had the opportunity to have as their April speaker Galen Schwertfeger an Environmental Protection Specialist with the Bureau of Land Management. Galen presented an overview on the BLM requirements for surface restoration and reclamation after a well is plugged. His overview asked "Why is Proper Reclamation Important? Answer Natural Resource Values

> Wildlife Habitat Visual Resources Livestock Forage Recreation Soil Stability Clear Water Clean Air Native Plant Communities.

The state of Wyoming because of their huge drilling activity has a more current reclamation policy which Galen did focus on. The goals are:

Short Term Goal: Immediately stabilize disturbed areas and provide conditions necessary to achieve the long term goal.

Long Term Goal: Facilitate eventual ecosystem reconstruction to maintain a safe and stable landscape and meet the desired outcomes of the land use plan.

An operator when filling an APD with the Federal Government addresses the reclamation process. There is an Interim Reclamation, and a Final Reclamation with basic reclamation steps. The main object is to stabilize all disturbed areas by redistribution of top soil, soil treatments, seeding or other steps to reestablishing vegetation, weed control, reclaim all disturbed areas including any access roads and pipelines.





Our April Membership meeting kicked off our annual Hasty Bake raffle fundraiser. Just in time for the 4<sup>th</sup> of July cookouts, this fundraiser is one of our favorites and helps to provide operating funds for our club. Our Fundraiser Committee Chair, Kim Dent, made arrangements with Hasty Bake to purchase one of their best-selling grills at a discounted price, she made flyers and tickets and handed them out at the April meeting. Let's aim for getting all committee rep positions filled this year! Step up and volunteer—it is one of the best moves you'll ever make!



### Set up:

As an endorser we are given a draped table, 2 chairs as well as 2 exhibitor badgers. Give away items are a must as they draw attendees to the booth. The EABs were a huge success. We gave away a \$50 Starbucks card in order to collect business cards.

#### Contacts:

We had a pretty steady stream of people on Thursday, a little less so on Friday. We found that the booth runs much better with a third person on the first full day of the expo (Thursday), but really only 2 are necessary on the second day. 
