The Wednesday Oct 10th Desk & Derrick Luncheon program was presented by our very own Susan Cook. With October meeting being our membership only meeting, it was a good time to renew the club's:

Purpose: The purpose of the Club shall be to promote the education and professional development of the individuals employed in or affiliated with the petroleum, energy and allied industries.

Motto: "Greater Knowledge – Greater Service"

Mission Statement: To enhance and foster a positive image to the global community by promoting the contribution of the petroleum, energy and allied industries through education, by using all resources available.

Susan Cook reviewed the responsibilities of the Desk & Derrick Club of Tulsa individual board positions. Since October is the month that the slate of officers is presented to and voted on by the membership from the nominating committee for the 2015 board this review was very important.

Orientation is a good opportunity for all members both new and as we call them, "seasoned" members to learn what goes into having an organization and the roles that the members play. Ms. Cook also went over all of the chairman positions within the club as far as the job functions and the importance of each of the chairs.

Historical facts of Desk & Derrick, including who started the organization, the reason for starting the club and the four original cities that began the Association of Desk and Derrick clubs was relived. April 1949 was a very good year because it was the beginning of the organization 65 years ago. In July 1951 our Association included the original four clubs – New Orleans, LA; Jackson, MS; Los Angeles, CA, and Houston, TX. By 1952 the first convention was in Houston with 46 clubs and a total membership of 4,782.

One of the years with the most clubs and members was 1983 with 127 clubs and 10,021 members.

In 1956 a central office was needed and a paid employee was hired. The Association Distribution Office (ADO) has been in Tulsa since its inception. (After all, Tulsa was once known as "the Oil Capital of the World". Andre' Martin has been in charge of the ADO since 2006.

There are 25 chairman positions within the club. Susan talked about each of the roles and the importance to making our club a success. There is something for everyone.

Ending the presentation Susan presented Football Jargon, incorporating Desk & Derrick Trivia along with Football Jargon with two teams of D&D members and a football. Go Team Tulsa!

Dear Fellow ADDC Members,

On behalf of the 2014 ADDC Contest Committee, "thank you" to all of the entrants in this year's ADDC AIMEE Contest and congratulations to the editors, authors, and coordinators of the entries that won the AIMEEs.

The judges' evaluation forms are being sent out via "snail" mail to club presidents if they were not picked up at Convention following the Member Recognition Luncheon. Take a few minutes to review the scores and judges' comments to help you understand where your entries did well and where you may have room for improvement.

The 2015 ADDC Contest Entry Forms are now available to use for preparing your club entries. Remember that all entry material must be presented or published during the period December 1, 2013 through November 30, 2014. This includes the Best Industry Photo category.

New this year is a tab "Contest Rules" which clearly spell out how the entries should be submitted and what may result in disqualification.

There are no changes to the categories that comprise the contest. The forms are again in Excel spreadsheet format, for ease of entry from the Official Entry Form to the Judge's Forms for each category. You just enter the information on the Official Entry Form, print it, get it signed by the incumbent club president or authorized member (such as Contest Committee Chairman, Club Vice President, etc.) and the information is populated on the Judge's Evaluation Forms for each category entered. Remember to send **FOUR COMPLETE SETS** of the entries per the Contest Rules.
