


Who was that masked woman?

### Program Recap

Rebecca Helt, Division Order Supervisor for WPX, was our guest speaker at the September luncheon meeting.

Rebecca is a Certified Division Order Analyst and Registered Professional Landman with more than 34 years' experience. She has served her member organizations, NADOA and SADOA, on the board of directors and as President, and received the distinction of *Analyst of the Year* in 2009.

From Mineralweb.com a Division Order is in force after the completion of a well and is an "instrument which sets forth the proportional ownership in produced hydrocarbons, including crude oil, natural gas, and NGL's. Sometimes the Division Order is referred to as a division of interest. More often than not, a single well or lease will have multiple owners. In fact, it's not uncommon to have hundreds of parties owning an interest in a single well."

Rebecca shared her passion for these land and royalty owners calling them the "greatest asset any company has." Imagine the loss of credibility, good will, and costs of improperly distributing a well's revenue to these owners — it's in everyone's best interest to get it right.

Over the span of her career, Rebecca shared that much has changed. Division Orders were once hand written or even scribbled on a piece of paper and an owner could have deeded a portion of his mineral rights to a neighbor for a loaf of bread – which was not uncommon during the Great Depression. Today's analysts must be computer-savvy, comply with state statutes and federal laws, understand the deregulation of natural gas, comprehend the entire oil and gas lease (which can be as long as 60 pages), and be aware of Sarbanes-Oxley reporting requirements.

Oil and gas leases involve all types of owners – Royalty Interest, Overriding Royalty Interest, Working Interest, Non-participating Royalty Interest, and Carried Working Interest each with unique decimal percentages of ownership. Researching all the owners in a section line has brought Rebecca much joy over the years. She treats these owners as family, has grieved upon hearing of a death from someone she personally got to know, and considers locating those who've fallen into suspense as a personal mission. She shared about finding an owner who had moved to California and was undergoing cancer treatment. With the \$90,000 that had been held in suspense and would now be released, this owner was able to pay a significant portion to cover medical expenses which was game-changing for the family.

Rebecca also commented on the ONRR, Office of Natural Resources Revenue, whose mission statement is "to collect, disburse, and verify Federal and Indian energy and other natural resource revenues on behalf of all Americans." Their website states that this effort is "one of the federal government's greatest sources of non-tax revenues." Their oversight of the industry has at times, created a tenuous working relationship with producers related to reporting deadlines, but operators are dedicated to working through these issues, avoiding penalties and sharing mutual knowledge for the benefit of the entire oil and gas industry.


