Dr. Bob L. Blackburn
Historian and Executive Director,
Oklahoma Historical Society

Bob L. Blackburn, a native Oklahoman, has served as Executive Director of the Oklahoma Historical Society since 1999. He joined the OHS in 1980 as editor of *The Chronicles of Oklahoma* and became deputy director for agency operations in 1990. He earned his M.A. and Ph.D. in History from Oklahoma State University.



Bob published several articles and his first book while still in graduate school, and has since written or co-authored 22 books and numerous articles, journal entries, and screen plays. He is a steady source of historical information to the media, and has appeared numerous times on the History Channel. He was instrumental in planning and building the Oklahoma History Center, a 215,000 square foot museum and research center with a budget of \$61 million.

Bob has served on numerous national and regional boards and committees, including the Western History Association, the Oklahoma Association of Professional Historians, the American Institute of Architects, and Leadership Oklahoma City. His hobbies are reading, running, carpentry, landscaping, and golf. Bob is married to former State Representative Debbie Blackburn and they have one son, Beau, who is a professional photographer in Colorado. Beau and his wife Torie have one son, making Bob and Debbie first time grandparents.

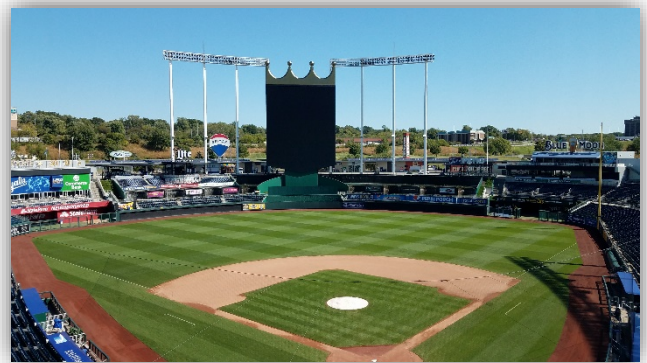

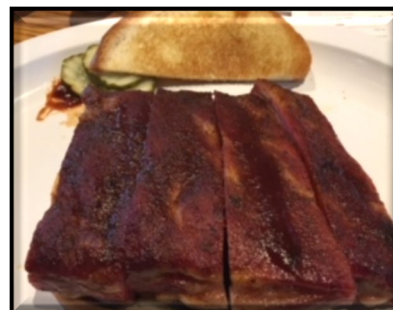

Magellan Pipeline Field Trip

The Central Region Enid Club did a great job setting up field trips. Kay and I went to Magellan Midstream Partners, Kansas City Regional hub for our first trip. We were welcomed by Kevan Heil and Tom Byers who surprised us with lots of yummy donuts, coffee and a very informative presentation about Magellan. We learned that Magellan has the longest refined petroleum products pipeline system in the US at 9,700 miles with 53 terminals. Going as far north as Grand Forks and Fargo, ND they have an impressive network of terminals south to Houston, east to Chicago and west to Cheyenne. They have access to nearly 50% of refinery capacity in the US, including Midcontinent and Gulf Coast refineries.

The Magellan pipeline system continues to be a critical piece of the Central US petroleum infrastructure that meets demands for refined products. The pipelines are carbon steel that vary in diameter that are generally 3-5 feet below ground. Products flow into the gathering system and enter the tank farm through a single pipeline, where multiple products and grades of gasoline go through a process called "batching". This process makes it possible for pipeline operators to meet the diverse needs of the nation. Now, we headed outside where Cory and Nick told us more about Transmix, fractionation, refined, denatured, distillates and biodiesel products. Regular to Premium gasoline, diesel and jet fuel, all in various mixes go to the terminal tanks and on into the semi-truck loading rack. It may sound overwhelming, but these guys gave us some great information about how all these amazing products that our companies drill for are stored, mixed and transported for our use around the nation and across the seas.

SubTropolis Field Trip

I have been to Kansas City many times but wow this trip showed me a whole new side of this city! I had no idea that a storage unit of this magnitude existed. I encourage anyone who has not gone to SubTropolis to put this on their list of places to visit in KC. SubTropolis is a 55,000,000-square-foot (5,100,000 m²), 1,100-acre (4.5 km²) artificial cave in the bluffs above the Missouri River. Developed by late Kansas City Chiefs owner Lamar Hunt via Hunt Midwest Real Estate Development, Inc., it has trademarked the phrase *World's Largest Underground Business Complex*.

Dug into the Bethany Falls limestone mine, SubTropolis is, in places, 160 feet (49 m) beneath the surface. It has a grid of 16 ft (4.9 m) high, 40 ft (12 m) wide tunnels separated by 25 ft (7.6 m) square limestone pillars created by the room and pillar method of hard rock mining. The complex contains almost 7 miles (11 km) of illuminated, paved roads and several miles of railroad track. Currently, more than 6,000,000 square feet (560,000 m²) is occupied and 8,000,000 square feet (740,000 m²) are available for future expansion.

So how did this enormous structure get started? Excavating for limestone, a great idea emerged. Why not open the pathways and empty spaces left from the excavating process for storage? Thus the SubTropolis was born. As they developed the idea of storage areas, they began to reconfigure the space to have more even pathways where trucks could easily travel. Trucks of all sizes easily navigate the underground tunnels to storage areas and production facilities. Some areas simply store artifacts, boxes waiting to be shipped out, orders waiting on us to click the link on-line and off to our house they go. One interesting business was the automotive companies that complete customized trucks and vehicles in the areas. So not just storage but a great place to work. At a constant temperature between 65 and 70 °F (18 and 21 °C) year-round, why sweat in the hot summer months or shiver in the winter when you can have a comfortable temperature without the cost of air conditioning or heat? A great idea. Companies take advantage of 30 cents rather than a dollar a square foot cost for utilities.

Organizations from the National Archives, Fed Ex, Hallmark and the IRS all take advantage of this amazing facility in the heart of the country, making Kansas City one of the most economical and robust cities in our nation.

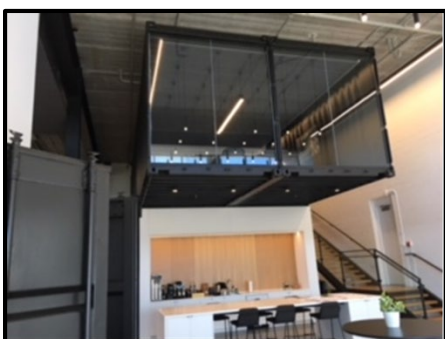
Port of KC Field Trip

Richard Grenville, Vice President of Multimodal Logistics was a very interesting host at PortKC. Richard is responsible for all Port Terminal Operations and business development of freight related business. He has had an extensive career in maritime industry, bringing a wide experience and innovations to the transportation/logistics field for PortKC. The port is located at Missouri River mile 367.1, near major national railroad yards, four interstate highways and is a true multimodal connector for transportation of goods. We found out that one barge is equal to 16 railroad cars or 70 truck trailers. So, you can see the efficiency of water transportation that would give the shipper a huge savings in cost to move products. Richard showed us a new office complex that has container boxes integrated into the design, much like our "Boxyard" area in Tulsa. We were bused to the PortKC water area where we saw big barges being unloaded. The barge Captain was always moving to adjust for the changes in water flow and the weight of the barge as product was being removed. The large arm of the excavator was lifting and unloading the product out of the barge to a huge mound on the bank. Then the front-end loader was moving product to the line of open trailers to head down the road to the customer. It was quite an efficient dance to see, knowing the guys work 24/7 constantly moving goods.

So, it makes me think, "how does this relate to the oil and gas industry?" Well, steel for the rigs and completion work are transported by water. Coal and road products are moved by water. Oil and other liquids are moved by water. Our transportation of goods, whether by water, rail or road, all intermix and work together at some point. Isn't commerce amazing? Do you remember that from Social Studies or Civics in Jr High?

Just as the water proved important to many industries, pipelines prove important to the oil and gas industry. To get closer to our geographic areas, around Midland in the Permian Basin, the trucking of oil and oilfield equipment requires thousands of semi-trucks on the road. The resulting road hazards and safety, along with state and county road repair all necessitated a pipeline to transport the oil in order to reduce road traffic and hazards. Once again, commerce working to improve our lives.

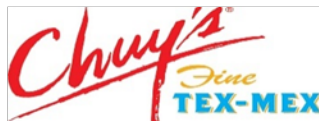
